Name of group	Inkberrow Millennium Green (IMG)
Brief description of project	<p>The aim was to manage IMG to sustain, restore and enhance a variety of habitats with ecological and social benefits for the Inkberrow community.</p> <p>IMG was set up in 1999 as a Millennium Green project – an initiative of the Countryside Commission supported by funds from National Lottery. Other funding came from Parish Council, private bodies and agreements with English Heritage and WCC (under section 39 of Wildlife and Countryside Act).</p> <p>The site is 2 fields with medieval moat and fishponds, lowland wildflower grassland (now designated SWS), copse, stream and wet flushes.</p>
Advice/ work delivered by Community Greenspace Team	<p>Management plan drawn up in 2001 under the guidance of Pauline Homer (WCC biologist?). Also ponds became part of Aqua Vitae 21 under Rachel Datlin.</p> <p>Our main contact over the past 8 years has been with Wade Muggleton from WCC Countryside Service who has given advice and guidance on a variety of issues whenever we have asked for help. He also organized BTCV work parties to help with scrub clearance on the island and has found time to visit the site himself to carry out some practical work coppicing hazel. He has always been our 'first port of call' when we needed advice.</p>

We started out with around £10000 with substantial grants from Millennium Greens project, Parish Council, WCC section 39 agreement. Also got some funding from Aqua Vitae21, English Heritage and private donations. More recently from charitable trusts, village societies and PC which gave us part of the proceeds from the village winning a Calor environment award (used to plant 4 oak trees).

The basic cost of running IMG is about £1000a year.
